- Online Orientation: Attendance is mandatory, as missing it could mean disqualification. Mark your calendars and be ready to participate!

While these contests won't advance to the national level (with the exception of National Spotlight on Projects), it's your chance to shine on the local stage and make a name for yourself in Idaho FCCLA.






## CURRENT EVENTS


#### **Hey FCCLA Members**,
